Opening of the Council Meeting

President Kevin Fletcher convened the Council via teleconference for discussion of needed changes to the language of the Local 305 By-Laws, Article VI – Union Vehicle. The meeting was called to order at 3:00 PM. Recording Secretary Derrick Carr conducted roll call (See Roll Call sheet).


Local By-Laws Article VI

The language of this section of the by-laws state that “The Union will maintain the current single vehicle.” President Fletcher stated that the Executive Board, at its most recent meeting, August 13, 2013, realized the need to do away with the present vehicle owned by the Union do to the increasingly high cost associated with maintaining it. He referred everyone to the minutes of the Executive Board meeting and discussed the expenses, fuel cost, taxes, and major repairs needed for the current vehicle.

After a brief discussion President Fletcher made a motion to change the first sentence of Article VI, Section 1, to read: *At the Local President’s discretion the Union may maintain a single vehicle.* The motion was seconded by Branch President Mike Smith and carried unanimously. The new language is effective immediately and will be recorded in the by-laws for next year.

President Fletcher than advised the Council of some changes at the Local office; after a brief discussion the meeting adjourned at 1:30 P.M.
