#### **OFFICIAL MINUTES**

Council Teleconference

November 23, 2015

The Council teleconference was called to order at 2:43 PM and roll call was taken by Recording Secretary Burnside. Thirteen (13) Council members present, nine (9) members absent.

In accordance with the ULUC Article IV, section 7, the purpose of the teleconference was to discuss the number of Delegates to send to the 2016 NPMHU National LIUNA Convention held in Chicago, IL from August 22, 2016 through August 27, 2016.

President Carr reminded the Council of its obligation to determine the number of delegates to send to the National Convention on or before November 30, 2015, in accordance with the NPMHU 2016 National Convention rules for delegate elections. (The Local President is automatically a Local Union delegate to all Conventions of this Union conducted during the term of office) The Council was informed of the Executive Board's decision to budget no more than \$75,000.00 total for "reasonable living and travel expenses" for the delegates elected. Total cost would include other expenditures decided by the Executive Board. Treasurer Cardin estimated that to send fifteen (15) delegates, it would cost the local about \$65,264.00.

After a lengthy discussion Branch President Douglas Grimm made a motion to send 16 delegates to the National Convention, one being the Local President. The motion was seconded by Treasurer Yam Cardin and carried forward by majority roll call vote.

Being no further business to discuss a motion was made by Branch President Charles Purdue to adjourn. The motion was seconded by DCSEBM Lamar Grigsby and carried forward unanimously.

The meeting officially adjourned at 3:27 PM.
