Delegates Convention

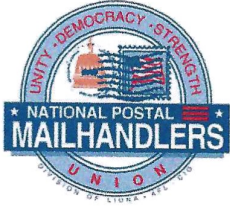
The National Delegates Convention was briefly discussed. To that end, the Council will be scheduled to convene on March 10th via Zoom to address pressing matters.
